Competition terms and conditions

5. The Entrant must provide a short paragraph (150 words) explaining why their supervisor is standout via the google form set up by the Promoter
6. The Entrant must upload a picture of themselves with their supervisor via the google form set up by the Promoter, or send their picture to communications@gpra.org.au
7. All valid, eligible entries received by the Closing Date will be judged on 20 December 2018. The winning entry will be selected on the merit of their answer ("the Winner").
8. The prize for the Winner is a Welch Allyn Premium Diagnostic set.
9. The prize is non-transferable and no cash alternative will be offered.
