

Cultural Safety and Education Grant 2024 Guidelines

About GPRA Cultural Safety and Education Grants

General Practice Registrars Australia (GPRA) – is the only national independent voice for future General Practitioners (GPs).

In 2024, GPRA will offer the opportunity for GP registrars (all pathways) to apply for Cultural Safety Education Grants.

Eligibility

GPRA encourages GP Registrars (all pathways) to consider accessing additional cultural safety and education development to support their training before arriving or whilst residing in the Northern Territory and/or their GP training. Applicants can apply for cultural safety education courses and/or purchase relevant resources.

Registrars, under this GPRA grant initiative, may be eligible for reimbursement of up to \$500 towards their cultural safety and education expenses and must be a member of General Practice Registrars Australia.

Application dates

Open: 8am, 1 March 2024 (ACST) Close: 4pm, 30 October 2024 (ACST)

We respect that GP registrars apply for and participate in different types of cultural education activities throughout the year. Applications will remain open during this time, so GP registrars can apply once they have paid and completed their eligible activity.

How to apply

Please submit the following information via the GPRA webform for consideration and assessment:

- · Full name
- Provider number
- · GP pathway, location and GPRA membership number
- · Name of course attended
- · Address/location of course/resource
- · In 300 words, provide a brief outline of
 - the course details
 - describe how this course/resource is relevant to your role
 - why you wanted to enrol in this course and/or purchased this resource(s), and
 - explain how this course/resource has improved your professional cultural understanding skills.
- · Bank account details
- · Upload all relevant course paid invoices and receipts
- Submit evidence of completion of education activity and/or purchase of resources Must be a member of GPRA.

Reimbursement expenditure

- · Reimbursements will be accepted up to a value of \$500 per activity (incl GST), per person, per year.
- · Applicants can only apply once per calendar year to the grants initiative.
- Reimbursements will be released only once evidence of attendance/completion re certificate/email confirmation is received from the recipient (submitted as part of the application).
- · If allocation of 2024 grant funds are exhausted, no further applications will be accepted.
- · All decisions of the grants officer are final.

Grant conditions

- Grant funds cannot be used for personal travel expenses such as accommodation, flights, and incidentals such as petrol and food.
- · Grant funds cannot be used for any expenses other than those associated with the approved activity.
- Each application will be assessed, and recipients will be reimbursed within one month of receipt of their application being considered and approved.

Reimbursement process

- · Recipients can only claim reimbursement in the financial year their grant was approved.
- · GPRA will not pay reimbursement to any individual other than the participant in the course.
- Recipients must upload evidence of course enrolment confirmation and completion, and/or purchase of resources, and include bank account details to which reimbursement funds are to be transferred.
- All reimbursement items claimed under this grant require tax invoices showing the supplier's name, address, ABN and GST amount.
- Payments will be made once the recipient has completed their cultural training activity, provided their receipts/ documentation, and provided their bank account details.

Cultural education courses and resources

For 2024, GPRA has compiled the following list of potential cultural safety and education providers as a guide only to help grant applicants. GPRA is not endorsing one course/resource over another.
